

Diploma of Business Traineeship Commencements

Your business MUST consider capitalising on this opportunity TODAY to maximise the benefits your business could enjoy.



Other Benefits

- Payroll Tax exemption for wages of ALL Trainees
- Wage subsidies are NOT sales hence should be excluded from any Franchisee Fee or percentage rent landlord sales declarations

Wage Subsidy Eligibility

Your business is eligible regardless of size, industry or geographic location, if:

- Your Trainee/s commence their Training Contract between 5th October 2020 & 30th June 2022;
- Your Trainee is a 'New Worker' ie. Full-Time less than 3 months or Part- Time less than 12 months;
- Your Trainee is an 'Existing Worker' but:
 - You're transferring them from a casual employment arrangement to either a part-time or full-time; OR
 - You're transferring them from a part-time employment arrangement to full-time
 - You are only enrolling up to 30 Existing Workers via complying with the above clauses
- You aren't already receiving another form of Australian Government wage subsidy for the Trainee e.g. Supporting Apprentices & Trainees OR JobKeeper (NB you could enrol a Trainee once they come off JobKeeper)

How & When Do I Receive the Wage Subsidies

- •The Australian Apprenticeship Support Network provider (eg. Busy, MEGT, MAS, etc) chosen to sign-up your Trainees will complete a Boosting Apprenticeship Commencements Registration form
- Payments are made quarterly directly into your nominated bank account
- When claiming you simply to present a signed copy of the Training Plan (which we'll provide you) + evidence
- confirming the gross wage paid to your Trainee (e.g. payroll prints, time and wages sheets or payslips)
